### Common Reporting Standard ("the CRS") 「共同匯報標準」

It is a set of rules developed by the Organisation for Economic Co-operation and Development (OECD). It calls on governments participating in CRS to obtain information from their financial institutions and automatically exchange that information with other jurisdictions on an annual basis. 這是由經濟合作暨發展組織(OECD)制定的一套規定。它呼籲參與 CRS 的政府從其金融機構獲取信息,並每年自動與其他司法管轄區交換該信息。

### Tax Residence 「稅務居民身分」

Under the CRS, we are required to determine where you are 'tax resident' (this will usually be where you are liable to pay income taxes). If your tax residence is outside Hong Kong (where your BOOM account is held), we may need to give the respective tax authorities the information in this information, along with information relating to your accounts. 根據共同匯報標準,我們須要確定閣下的納稅居住地(這通常是閣下須要繳納入息稅的地方)。若閣下的稅務居民身分地在香港(持有 BOOM 帳戶的地方)以外,我們可能須要向相關稅務機關提供本表格的信息以及與閣下賬戶相關的信息。

### Taxpayer Identification Number ("TIN") 「納稅人識別號碼」

It is a unique number assigned by a government to an individual or an Entity and used to identify them for tax purposes. Some governments do not issue a TIN but might use some other number such as a social security/insurance number, citizen/personal identification/service code/number, or resident registration number. 它是由政府分配給個人或機構的編號,用於識別其稅務身份。一些政府或不會發出稅務編號,但可能會使用其他身份證號碼代替,例如社會保障/保險編號,公民/個人身份號碼或居民答記號碼。
